

SUBMISSION AND OPENING OF PROPOSALS/BIDS

1. Bidders may submit their Quotations by post.
2. The envelope shall;
 - (a) Bear the name and address of the Bidder
 - (b) Be address to the Purchaser.If envelope is not sealed and marked as required the Purchaser will assume no responsibility for the misplacement or premature opening of the bid.
3. The Purchaser shall not consider any quotation that arrives after the deadline for submission of bids. Any bid received by the Purchaser after the deadline for submission of quotation shall be declared late, rejected, and returned.
4. The Quotation will be received up to 12.06.2019 till 11.00 AM in the office of the Secretary, BISE, and Multan. and shall be opened on the same day at 11.30 AM in the presence of bidders or their representative who make them available on that date and time in the committee room of the Board.
5. Bid Security @ 5% on total estimated Price of Bid in favour of Secretary, BISE, Multan in the shape of pay order / Bank Draft or CDR issued by any scheduled bank Should be attached with the Bid.
