


RECOMMENDATIONS OF THE PURCHASE COMMITTEE

- M/S Junaid Traders Lahore**, being lowest bidder @ Rs.1,484/- (One thousand four hundred & eighty-four rupees only) per ream of White Offset Paper Imported Size: Legal, 8-1/2x 13-1/2 GSM: 80 & total amount of which is Rs. 2,968,000/- (Two million nine hundred sixty-eight thousand rupees only) in the category reflected above at Sr. No.01, **is hereby recommended as successful bidder** subject to the condition that no grievance is received from technically qualified firms within 10 days after uploading the comparative statement on EPADs, PPRA & Board's websites in accordance with PPRA Rules, 2014.
- ii. **M/S UBC Converttech Lahore**, being lowest bidder @ Rs.1,313/- (One thousand three hundred & thirteen rupees only) per ream of White Offset Paper Imported Size: Legal, 8-1/2x 13-1/2 GSM: 70 & total amount of which is Rs. 15,756,000/- (Fifteen million seven hundred fifty-six thousand rupees only) in the category reflected above at Sr. No.02, **is hereby recommended as successful bidder** subject to the condition that no grievance is received from technically qualified firms within 10 days after uploading the comparative statement on EPADs, PPRA & Board's websites in accordance with PPRA Rules, 2014.
- iii. **M/S UBC Converttech Lahore**, being lowest bidder @ Rs.1,048/- (One thousand & forty-eight rupees only) per ream of White Offset Paper Imported Size: A-4, 8.2x 11.6, GSM: 80 & total amount of which is Rs. 8,384,000/- (Eight million three hundred eighty-four thousand rupees only) in the category reflected above at Sr. No.03, **is hereby recommended as successful bidder** subject to the condition that no grievance is received from technically qualified firms within 10 days after uploading the comparative statement on EPADs, PPRA & Board's websites in accordance with PPRA Rules, 2014.
- iv. It is imperative to mention here that estimated cost of the tender duly advertised in the tender (all three categories) was calculated / mentioned amounting to Rs. 34,000,000/- (Thirty-four million rupees only) whereas lowest offered rates of all three categories are Rs. 27,108,000/- (twenty-seven million one hundred eight thousand) which is within the limit of estimated cost, therefore, Purchase Committee unanimously recommended to approve the lowest offered rates by the firms mentioned in the recommendations at Sr. No. i., ii. and iii.
